

AGREEMENT

This agreement made this day of 2017

BETWEEN: SOUTHLAND TRAILER YACHT SQUADRON INC (hereinafter called "the organiser")

A N D: (hereinafter called “the exhibitor”)

WHEREAS:

- A. The organiser is holding a Boat Show at Stadium Southland, in Invercargill on 12-13th August 2017 and for that purpose has hired part of the stadium from Southland Indoor Leisure Centre Charitable Trust; and
- B. The organiser is providing trade space to interested exhibitors to display their products at the Boat Show; and
- C. The exhibitor wishes to exhibit its products at the Boat Show.

THE PARTIES HEREBY AGREE AS FOLLOWS:

1. The organiser agrees to provide to the exhibitor a site of square meters for the duration of the Boat Show.
2. The exhibitor agrees to pay \$.....for the use of the site.
3. The exhibitor shall be granted access to the site from 10.00 am on Friday 11 August 2017.
4. The exhibitor shall vacate the site by 9.00 am on Monday 14 August 2017.
5. The exhibitors' site shall be left in the same condition as it was at the beginning of the hire.
6. The organiser shall arrange electrical drop outlets as reasonably required by the exhibitor.

7. The exhibitor shall ensure that all displays comply fully with all Health and Safety legislation and requirements and shall be solely responsible for any liability arising out of or otherwise connected to the exhibitor's display or use of the site. The exhibitor absolutely indemnifies the organiser for any such liability.
8. The organiser shall have no liability to any exhibitor or third party over the content of any exhibitor's display. The exhibitor absolutely indemnifies the organiser for any such liability.
9. The exhibitor agrees to abide to the following conditions imposed by Stadium Southland.
 - ☐ No motor vehicles are permitted in the building.
 - ☐ All boats to be placed on site by the organisers.
 - ☐ All petrol must be taken out of the boats (please notify organisers of any issues here).
 - ☐ No items are to make direct contact with the floor of the building.
 - ☐ Stadium management and organisers to be aware of any high masts in the building.
 - ☐ No exhibitors to have helium balloons in the building.
 - ☐ The whole building is smoke free.
 - ☐ No partitions are to be used other than the ones allocated by the organisers.
 - ☐ No food or drink to be taken into the Events Courts 1 & 2 and the 5 Community Courts.
10. The organiser reserves the right to expel the exhibitor from the Boat Show for any breaches of the conditions in this agreement or for such other reason or reasons the organiser may determine at its sole discretion.
